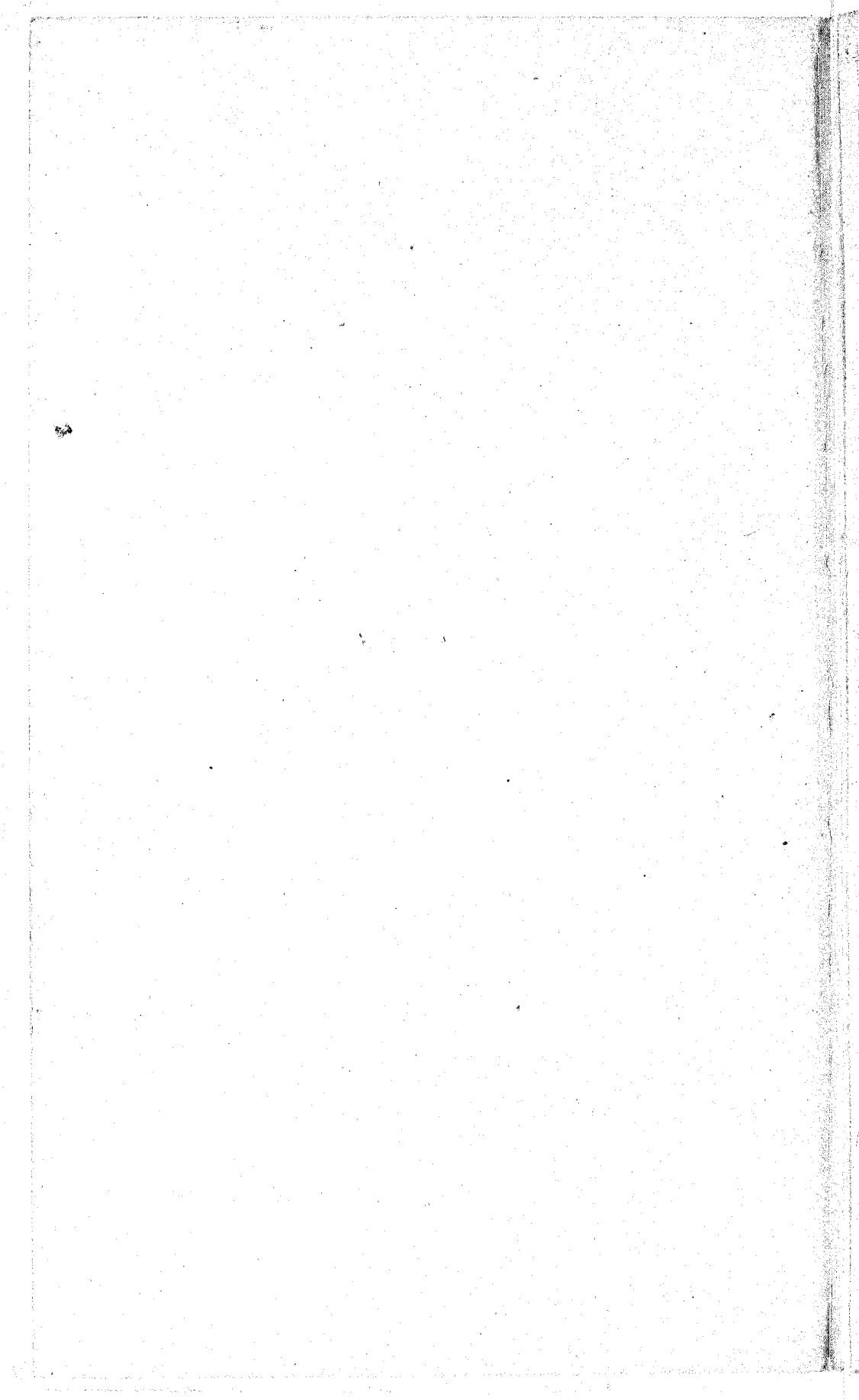

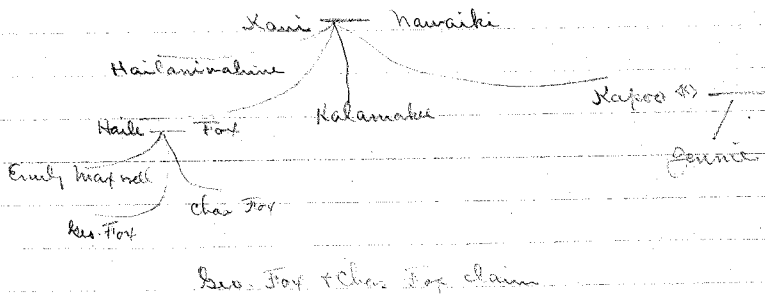

I. SHARE OF LIMA (k) IN HUI OF MAILEPAI.

This has heretofore been classified as "good" (See letter to H. P. Baldwin, July 18, 1899, p. 5). The chain is as follows:

By its terms this deed purports to cover the share of Lima (and also that of Pochina) in the Hui of Mailepai, and also in the Hui of Kahana.

(Note: Mrs. Baker's title evidently depended on that of John Baker, she probably having claimed as his widow and sole heir. This, however, is not of record).

This deed does not refer to any hui shares, but in terms

purports to convey "all those premises at Kaanapali, Maui, described in Royal Patent 1663, Land Commission Award 5524 . . . and including and being the Ahupuaas of Napili, Honokeana, Alaeloa, and Mailepai, with a combined area of 2825 acres; and also all those premises at said Kaanapali described in R. P. (Grant) 1166 to D. Baldwin, J. P. Pogue and S. E. Bishop, being the land of Kahana, with an area of 2675 acres".

So far as any person now claiming title as an heir of Lima to his share in Mailepai, against Mr. H. P. Baldwin, is concerned; it seems to us that although Lima's conveyance is termed a "Bill of Sale" and is in poor Hawaiian phraseology (examined and translated by Mr. W. O. Smith), and although it has not been acknowledged or recorded, still if it was genuinely signed by Lima himself, as on its face it purports to have been, it is good to pass title to Lima's share in Mailepai, and estop anyone claiming as heir of Lima from now asserting ownership. As against any such person Mr. H. P. Baldwin would have good title. This inquiry does not extend to investigating any possible claim by any "heir" of John Baker.

II. SHARE OF LIMA (k) IN HUI OF KAHANA.

There is no record of Lima having made any conveyance of his title to this share. The first deed of record is that of Pohano, his widow, to L. M. Baldwin, dated September 25, 1889, recorded in Liber 122/98, by which Pohano purports to convey this share. Her title does not appear. If Lima died without children, as seems to have been the case in view of the pedigree sketches given below, his property would go to his wife (1/2) and the other 1/2 to any brothers and sisters. Among the papers relating to this share are two sketches of pedigrees, one indicating that Lima was one of six children, and the other

that he was one of three. The first mentioned sketch was worked out by Wm. White, of Lahaina, and is in the form of a report dated Sept. 6, 1899, addressed to Mr. R. C. Searle. We here copy the same at length:

Dear Sir,

In regard to your inquiries concerning the pedigree of Lima, I have found the following:

Kamaha (k) married Kahaiea (w) and they had six children, viz: (1) Palina (w), (2) Lima (k), (3) Pupuka (w), (4) Palinaopio (w), (5) Kahananui (k), and (6) Kamaha (k). See the following genealogical tree:

The above mentioned Kahananui is living at Waialua, Oahu.

Palina(w) married Nauaua(k) and had one child Kaulaula(w) who married Hoaiiki(k), and they had three children, Kaulaula(w), Holau(w), and Hoaiiki(k), who died very young. (Note: Mr. White here means that only Hoaiiki (Jr) died very young).

Kaulaula(w), daughter of Kaulaula and Hoaiiki, married Isaac Smith (Aikake) and had no issue. Kaulaula is dead and her husband Isaac is still living at Molekai. Holau(w) is living at Olowalu, Lahaina, and is the wife of Kanawaliwali Namealoha.

Lima(k) married Pohano(w) and had no issue. Said Pohano outlived her husband Lima, and sold her 1/2 interest in Kahana to H. P. Baldwin, but not her 1/2 interest in Mailepai. Pohano was fully certain (before she died about two or three years ago) Lima her husband never sold his Mailepai interest to S. H. Hui (or Kui) or anybody else, and she never signed to any other deed except H. P. Baldwin's. Kahananui, the brother of Lima, was the one who sold the Mailepai interest of Lima to Edwin Jones when said Kahananui was here in Lahaina some time after the death of Lima.

"Kahanu, the son of said Pohano by her former husband Kapahi still claims the 1/2 interest in Mailepai which his mother is entitled to.

"Pupuka(w), one of Lima's sisters, married Kuhia(k), and had three children. Parents and children all left Lanai and went to Waialua, Oahu. Do not know the names of the three children for certainty.

"Palinaopic(w), the youngest sister of Lima, married Kaimihau(k) and had a child named Kaulaula. They all died before Lima.

"Kahananui, one of Lima's brothers, is living in Waialua, Oahu, or in Honolulu, a sailor by profession. He married by the name of Malie (i. e. - a woman named Malie), and had no children. He was the one who sold the Mailepai interest of Lima to Edwin Jones.

"Kamaha(k), the last brother of Lima, is dead. He never married.

"According to the foregoing, the property of Lima goes to the following persons, and to be divided proportionately amongst, thus:

Pohano, Lima's widow, 1/2 of the whole estate, 1/2

The remaining 1/2 to the following:

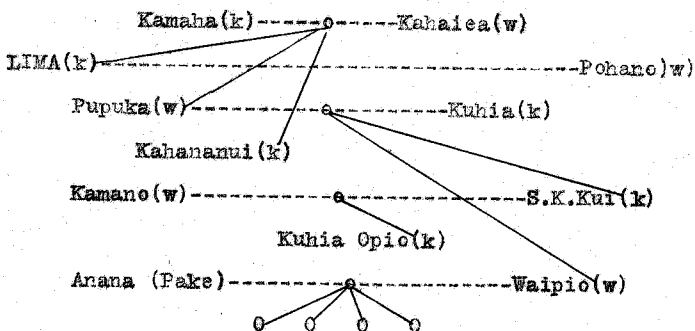
- Isaac Smith, husband of Kaulaula, grandchild
of Palina, 1/6
- Holau(w), grandchild of Palina 1/6
- First child of Pupuka, 1/9
- Second child of Pupuka 1/9
- Third child of Pupuka 1/9
- Kahananui, Lima's surviving brother, 1/3

"I remain, Yours respectfully,

The recital in Wm. White's report, that Pohano did not sell her 1/2 interest in Lima's share in Mailepai, is of little weight, as she did not have any interest in that share to dispose of, Lima having sold it to L. M. Baldwin in his lifetime. Her son, Kahanu, by her former husband, could not, therefore, have an interest in Mailepai as her heir. The fractions given in the summary of White's report relate to a half interest only, and should be reduced 1/2 with respect to the whole.

The other sketch of pedigree mentioned, shows only Lima, Pupuka and Kahananui as the children of Kamaha and Kahaiea. In illustrative form this sketch is as follows:



Noted on this sketch is the statement that S. K. Kui claims 3/8, viz., 1/4 from Kahananui by deed, and 1/8 by inheritance,

and that the remaining 1/8 belongs to Waipio.

It will be noted that although this sketch gives but three children of Kamaha and Kahaiea, it gives the names of two of the children of Pupuka, viz. S. K. Kui and Waipio.

Also, although Kahananui may have sold his interest in Kahana to S. K. Kui, he may not have sold his interest in Mailepai (if any) to Kui, as White's report mentions that he sold this to Edwin Jones, who sold to L. M. Baldwin who in turn sold to Mr. H. P. Baldwin.

We are of opinion that Mr. H. P. Baldwin has good title to an undivided one-half part of Lima's share in the Hui of Kahana, and that the remaining one-half is outstanding in the heirs of Lima, whoever they may be at this date.

III. SHARE OF PILAHAKA IN THE HUI OF KAHANA.

The sufficiency of this title in Mr. H. P. Baldwin depends upon the truth of the recitals of heirship in the deeds. These are not consistent however. We give the chain of title from the deeds at hand, as follows:

By its terms (as translated) this deed recites that it conveys to Mookini all the undivided share of the "deceased brother" of Kaahanui in the Hui land of Kahana. The brother is named as Pilahaka, to whom, with others, the hui land was conveyed by S. E. Bishop and wife by deed of Feb. 17, 1862.

the Hui land of Kahana . . . conveyed to grantor by deed of Kaahanui by deed dated Aug. 23, 1898, recorded herewith, "the said Kaahanui having inherited said share as follows: Upon the death of Pilahaka, without issue, his property descended to his mother, Keakaku(w), and upon her death without issue descended to Luluhi(k), her brother who was married to Ehukuwala; they had three children, Kaoni(w), Kalawaia(k) and Kaoniopio(w). Kaahanui(w) was the daughter of Kaoni(w) and the sole surviving heir to the land of Kalawaia,-- Kalawaia(k) and Kaoniopio(w) having died without issue."

Under this pedigree, Kaahanui was far from "sister" of Pilahaka.

In any case there is no other deed of record to dispute Kaahanui's claim of heir-ship, whatever the source.

We hesitate to pronounce Mr. Baldwin's title "good", but think he should purchase no adverse claim without clear proof of some valid title in the claimant.

IV. SHARE OF WAHIE IN THE HUI OF KAHANA.

There is no conveyance of record from Wahie, and no indication of heirship in anyone. The first deed of record came from Edwin Jones to L. M. Baldwin, July 30, 1889, recorded Aug. 14, 1889 in Liber 117/323. This did not specifically name the share of Wahie. This was followed by a second deed from Ed-

win Jones and wife to L. M. Baldwin, dated Oct. 11, 1889, recorded Oct. 12, 1889 in Liber 118/386, which mentioned various other hui shares (not naming that of Wahie in Kahana), but concluding with the general conveyance "and all other shares in the Hui lands of Chas. R. Bishop and B. Pauahi Bishop, and Sereno M. Bishop and M. Kekaiionchi, and known as the lands of Mailepai, Kahana and Moomuku in Kaanapali, Lahaina, Maui".

Following this Edwin Jones and wife executed a third deed to L. M. Baldwin, dated Jan. 16, 1890, recorded Liber 122/62, which purports to convey a large number of shares in these Huis, reciting the names of the original shareholders, the name of Wahie being included among the number. This deed contains the express provision that "It is hereby understood that the said Edwin Jones does not warrant and defend the above granted shares".

Mr. L. M. Baldwin included the share of Wahie in his conveyance of these various Hui shares to Mr. H. P. Baldwin.

The title of Mr. H. P. Baldwin in the share of Wahie in the Hui of Kahana is therefore questionable.
